Three Angels Farms (Dorian Ayache) from Lebanon, TN is in the business of selling horses to slaughter for human consumption. This company has run under two different DOT numbers in the past. When Mr. Ayache was asked by an investigator with the Department of Transportation why he had two DOT numbers, he stated that he had a bad record so he just opened up another company under his brother's name.

In July a new trucking company out of Murfreesboro, TN called Terri's Farms was formed. Did Three Angels farms reincarnate into this new company? Paperwork shows the same trucks and the same

trailers that were used for Three Angels Farms, are now being used for Terri's Farms. One particular document even has Dorian Ayache listed as the driver of the shipment. I guess the question that really should be asked, is if the business arrangement between Dorian Ayache and the owner of Terri's
